

THE CORPORATION OF THE CITY OF DRYDEN

BY-LAW NUMBER 3635-2008

BEING A BY-LAW TO AMEND CHAPTER 72, FEES AND CHARGES, OF THE MUNICIPAL CODE OF THE CORPORATION OF THE CITY OF DRYDEN.

WHEREAS the Council of The Corporation of The City of Dryden deems it necessary and expedient to amend Chapter 72, Fees and Charges, of the Municipal Code of The Corporation of The City of Dryden by adding Schedule “J” – Cemetery Price List which establishes and amends fees on the Cemetery Price List.

NOW THEREFORE the Council of The Corporation of The City of Dryden enacts as follows:

1. THAT Chapter 72, Fees and Charges, of the Municipal Code of The Corporation of The City of Dryden be hereby amended by adding Schedule “J” – Cemetery Price List as follows:

Schedule “J” - Cemetery Price List

This Price List is subject to the provisions of sections 26 and 27 of the Cemeteries Act (Revised), R.S.O. 1990, c. C.4.

Rates proposed include the \$10.00 per interment licence fee to the Province. Plus GST.
