



## Notice of Special Meeting of Council

### Relating to the City of Dryden Official Plan Review

Pursuant to Section 26 of the Planning Act, R.S.O. 1990, c.P.13, and in accordance with Chapter 47, Section 47-19 L. of the City of Dryden Municipal Code, The Corporation of The City of Dryden is required to hold a special meeting of Council that is open to the public to discuss revisions that may be required to the City of Dryden Official Plan. The special meeting of Council will be held on:

**The purpose of this meeting** is to provide residents, property owners and business operators in the City of Dryden with the opportunity to provide comments and identify revisions that may be required to the current Official Plan to conform to Provincial Plans, have regard to matters of Provincial interest and be consistent with the Provincial Policy Statement.

The meeting will include a brief presentation from the City's Planning Consultants, in which they will discuss planning changes that have occurred since the current Official Plan was approved by the Minister of Municipal Affairs and Housing in 2005. Following the presentation from the Consultant, the public will be invited to address Council and provide comment.

A copy of the current Official Plan is available for review in the Municipal Office or on the Official Plan review web page located on the City's website at [www.dryden.ca](http://www.dryden.ca). A copy of the agenda for the special meeting of Council and all attachments will be available to the public under the Council section of the City of Dryden website by close of business on the Friday prior to the meeting on Monday, March 21, 2011.

Documentation, maps and policies to be included in an amendment to the Official Plan to meet the requirements of the review process will not be identified at this meeting. There will be other public meetings and open houses that will be scheduled over the coming months at which time these documents will be considered and made available for public review and opportunities for public input provided. Notices of these meetings will be posted to the City of Dryden website, the local newspaper, the Library, Recreation Complex, and Clerk's Office.

Any person may attend the special meeting of Council and/or provide written or a verbal representation.
