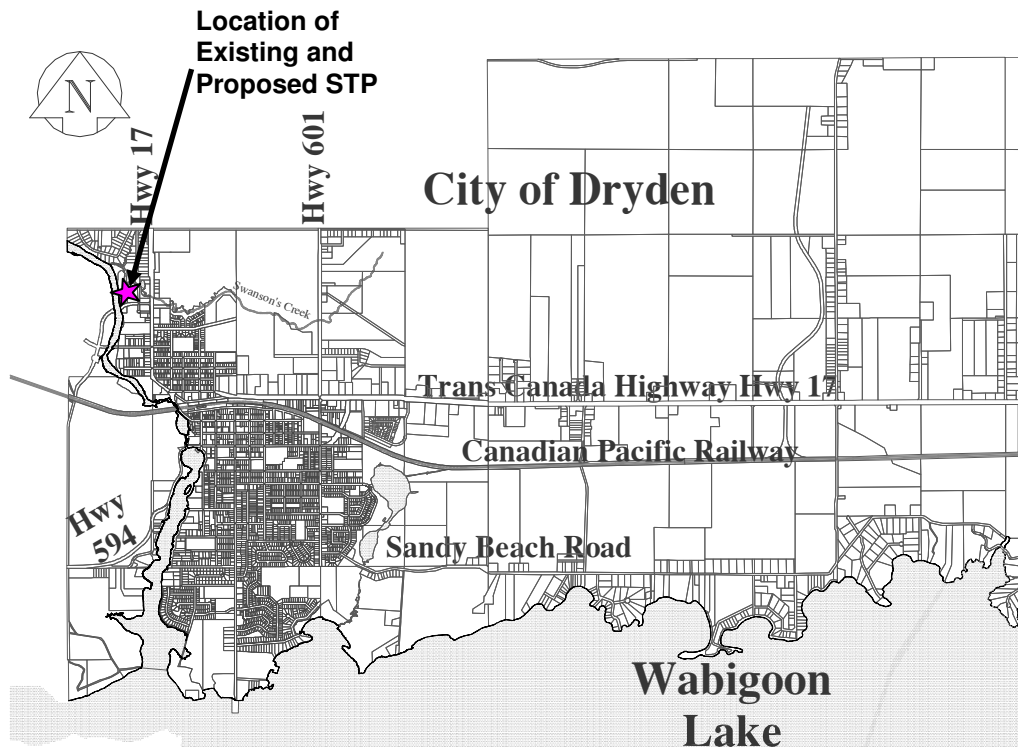




**CITY OF DRYDEN  
CLASS ENVIRONMENTAL ASSESSMENT  
PROPOSED SEWAGE TREATMENT PLANT (STP)  
NOTICE OF COMPLETION OF ENVIRONMENTAL STUDY REPORT**

The City of Dryden, through its consultant AECOM, previously completed a Land Use Implementation and Servicing Plan Study (July 2008) which evaluated the state of the current infrastructure and upgrading requirements for Dryden's anticipated future population. It also included a comprehensive plan for system upgrading over the next 20 years. The Study recommendations have provided a basis for the design of a proposed replacement sewage treatment plant (STP) for the City of Dryden. This has been identified by the City as a key infrastructure improvement, which will replace an aging facility, reduce environmental impacts and facilitate further residential or commercial development.

**Site Location**



In accordance with the requirements of Phases 3 and 4 of the approved Municipal Class Environmental Assessment (Class EA) process (Schedule C), an Environmental Study Report (ESR) has been completed. This report documents the planning process followed to arrive at the preferred solution for a replacement sewage treatment plant (STP), as well as the anticipated environmental impacts and proposed mitigation measures associated with the project.

If concerns arise regarding this project, that cannot be resolved in discussion with the municipality, a person or party may request that the Minister of the Environment make an order for the project to comply with Part II of the Environmental Assessment Act (referred to as a Part II Order), which addresses individual environment assessments. Requests must be received by the Minister at the address below within 30 calendar days of March 10, 2010. A copy of the request must also be sent to the City of Dryden Study Contact, provided below. If there is no request received by April 9, 2010, the Proposed Sewage Treatment Plant (STP) will proceed to final design and construction.
