After the disbandment of the Dryden Police Service on February 24th, 2022, Section 10 of the PSA will apply to the Dryden Police Services Board. The municipality will have a financial relationship and the Board an advisory relationship with the Ontario Provincial Police as per the Agreement. The PSA and the Agreement are silent as to the relationship with the Municipal Council. T. Gervais suggested that a reporting mechanism be put in place between the Board and Council.

Board members took the opportunity to ask questions and to clarify matters of concern.

The Board thanked T. Gervais for his presentation. At this point he left the meeting.
