(a) OPP Quarterly Report

Commander Illman gave an overview of his 2023 First Quarter Report. He advised there was a public complaint that had since been withdrawn so it was not reflected in the report. Mr. Bates asked for some clarification on the Crime Abatement Strategy. Inspector Illman gave an overview of what the strategy includes. Inspector Illman included a detailed review of the staffing updates for the quarter. In his overview, he noted that the report shows 2 abductions but believes they have been inputted by mistake. R. Cunningham gave some detail on the statistics relating to violent crime and clearance rates. He then went into some detail about the statistics included in the Property Crime section. Inspector Illman advised that there will be increase foot patrol in the downtown area as the weather begins to get better. A member of the street crime unit gave an overview of the Drug Crime stats listed in the Quarterly Report. G. Bates asked if there were any specific drugs that are showing up more frequently. The street crime unit advised that fentanyl is increasing in the area. G. Bates asked for clarification on what an eTicket is. Inspector Illman detailed what an eTicket is and how the process works.

8. Business:

(a) Zone 1 AGM Attendance

No members of the Police Services Board expressed interest in attending the Zone 1 Annual General Meeting.

(b) Moving of Police Services Board Meeting to City Hall

K. Moss noted that he thought the meeting should continue to be held at the OPP Board Room to make it easier for the OPP members. M. Price shared that there was a lot of public interest in the last Council meeting at which the OPP Attended and suggested that City Hall would be better for transparency as there is the ability to stream and record the City Hall meetings. She also asked if it would be difficult for the OPP members to attend at City Hall. There was then some discussion about the pros and cons of moving the meeting. K. Moss advised that the most important thing for him is to keep the meeting at the OPP Board Room citing "ease of information" on the OPP side. G. Bates shared that he feels things may not be as open if the meetings were streamed and recorded. K. Moss shared the same sentiment about meetings being more open if meetings were streamed and recorded. J. Harrison shared that being on camera can have an effect but also thinks the streaming and recording would be beneficial to the public. J. Carlucci shared the reason for having the vote noting that in the past it was discussed but a decision was not officially made.
