Title: Police Costing Committee Update – Proposal Review Schedule

#### **Recommendation:**

That Council accept this report as information and approve the OPP proposal review schedule (Table 1) as presented by the CAO.

## **Background:**

Council passed a motion on October 26th, 2020 to request a contract police service proposal from the OPP. Additionally, Council formed a committee of council, the Police Costing Committee, to oversee a credible and professional process for the review of the OPP policing contract proposal. Council representatives appointed to this committee are Councilor Bush, Councilor Martin MacKinnon and Councilor Price. The City CAO, City Treasurer and Acting City Clerk also sit on this committee.

The Police Costing Committee, under City Council direction, contracted MNP LLP to conduct an update to their Study and Analysis of Policing Services that was completed for the City in 2019. The original study was completed to provide information to the City to inform the City's decision-making process regarding policing model options.

The OPP delivered their contract policing proposal on May 17, 2021 which initiates a City Council review process not to exceed 6 months.

Staff Report Title: Police Costing Committee Update – Proposal Review Schedule

### **Discussion:**

Over the course of the last 5 months, MNP has been engaged in the work to develop the update to their 2019 Study and Analysis of Policing Services report. This work has consisted of the following,

- Update the two forces service offering comparison
- Consult with chosen Ontario municipalities that have made changes in their own policing models
- Consult with the DPS, the OPP and other primary stakeholders to capture changes or new information since the last study
- Update the Calls for Service modelling with 2019 data
- Update the financial model and financial projections with 2019 data
- Provide benchmarking data

Based on the delivery of the OPP's contract policing proposal on May 17, 2021, MNP and the City now have the final information required to complete the update to the 2019 Study and Analysis of Policing Services report. Additionally, with the OPP proposal delivery complete, City Council now has up to 6 months to review the proposal and make a decision to either accept or reject the proposal and notify the OPP of their decision.

The Police Costing Committee is hereby submitting the below schedule of events and milestones that will lead council to a decision regarding the acceptance or rejection of the OPP costing proposal.
