4. <u>Agenda Items:</u>

(a) <u>Terms of Reference Revisions - CAO.</u>

Mr. Remillard advised he would be making some changes to the Terms of Reference he had previously proposed. These would include noting that himself, Mr. Lansdell-Roll and Chief Palson are staff resources to the Committee and that Ms. Euler and Ms. Kincaid are admin support and that none of these individuals have voting rights on the Committee. He advised he would also be adding an end date to the Committee in the Terms of Reference, proposing November 30, 2018 or upon a decision of Council. Committee discussed the November 30 date, suggesting that it could be earlier if, on the close of nominations for the 2018 Municipal Election, Council is lame duck. Mr. Remillard advised Ms. Kincaid had a municipal lawyer looking into the implications of lame duck on this Committee and a Council decision on the issue. Mr. Remillard advised he had re-iterated to Council that he was to be the City of Dryden spokesperson on the Police Costing issue.

(b) News presented by communities choosing to transition and others that have not - CAO.

Mr. Remillard distributed information and recent news briefs regarding police costings and advised he had emailed them to Councillors Bush and Carlucci too. He noted he had created a list of contacts from municipalities that had decided to move to the OPP and those that had not for upcoming phone interviews about their experiences. He also advised there was no update from the OPP with regard to the building issue but that he would advise the Committee when he has new information.
